CONDITIONS OF SUPERVISION

In consideration of having been granted supervised probation. I agree to report to my Probation Officer according to the instructions I have received and the following conditions:

- I will obey federal, state and local laws and ordinances, and all orders, rules and regulations of Noble County Court. I agree to conduct myself as a responsible lawabiding citizen.
- 2) I will always keep my Probation Officer informed of my residence and my place of employment. I will obtain permission from my supervising officer before changing my residence or my employment.
- 3) I will not leave the State of Ohio for more than a week without notification to my supervising probation officer.
- I will follow all orders, verbal or written, given to me by my Probation Officer, or the authorized representatives of the Court. Additionally, I understand that my supervising officer will notify me of my scheduled appointments at each scheduled office visit and it is solely my responsibility to keep my scheduled appointments. Should I lose, throw away, forget, or otherwise misplace my appointment letter, I understand that additional sanctions may be imposed on a case-by-case basis.
- I will not purchase, possess, use or have under my control any narcotic drug or other controlled substance or illegal drug. This includes any synthetic or man-made substance, legal or illegal, used as a mood-altering material. This also includes any instrument, device or other object used to administer drugs or to prepare them for administration,

unless it is lawfully prescribed for me by a licenced physician. I agree to inform my Probation Officer promptly of any such prescription. I agree not to possess or consume any alcoholic beverage if that is a condition of my probation. I agree to submit to drug/alcohol testing upon verbal order of my Probation Officer or the authorized representatives of the Court. Once notified that I am to submit to drug/alcohol testing, I agree to provide a urine sample within 90 minutes.

- I will report any arrest, citation or a violation of the law, conviction or any other contact with a law enforcement officer to my Probation Officer no later than the next business day. I will not enter into any agreement or other arrangement with any law enforcement agency which might place me in the position of violating any law or condition of my supervision, unless I have obtained permission in writing from my supervising Probation Officer.
- I agree to search, without warrant, of my person, purse or wallet, including cell or smart phone, and any electronic devises, including computers and any components, my motor vehicle, or my approved place of residence by a Probation Officer or other authorized representative of the Noble County Court at any time. I also understand that Law Enforcement Officers may accompany Probation Officers on any such search. All searches will be based on reasonable grounds and will be conducted in compliance with §2951.02(A) of the Ohio Revised Code.
- 8) I agree to sign a release of confidential information from any public or private agency if requested to do so by a supervising officer.
- 9) I agree not to knowingly associate for the purpose of criminal activity, with persons having a criminal background, felony or misdemeanor, and/or persons of questionable character, or who may have gang affiliation. This includes any contact that is face to face, or through electronic devices such as computers, internet, telephones, or cell phones. If my crime was a sex offense, I shall have no contact with anyone under the age of 18.
- 10) I will have no contact with the victim.
- 11) I agree to comply with all financial obligations as ordered by any court.
- 12) I agree to give all information regarding my financial status to assist in determining my ability to pay specific financial obligations to my Probation Officer.

- I agree to follow all rules and regulations of treatment facilities or programs of any type in which I am placed or ordered to attend while under the jurisdiction of the Court.
- I agree and understand that if I am arrested in any other state or territory of the United States or in any foreign country, my signature as witnessed at the end of the page will be deemed to be a waiver of extradition and that no other formalities will be required for an authorized agent of the State of Ohio to bring about my return to this state.
- I agree to fully participate in, and successfully complete, the following indicated sanctions and/ or special conditions:
